

SEASON LOCKER TERMS OF USE AND AGREEMENT

Any authorized Locker co-users must be either User's **IMMEDIATE** family (spouse & children) or **ONE** other **adult ONLY**, as identified below. After having informed Resort's Locker Room staff, guests are welcome in the Locker Room temporarily and **ONLY WHEN ACCOMPANIED BY THE USER**. User must inform co-users of this policy and they are bound by all terms of this agreement. My **ADDITIONAL AUTHORIZED LOCKER USERS**, if any, are:

1. I assume all risk of injury, loss, damage, theft, and/or vandalism to any property or person in the Locker, Locker Room, or at the Resort from whatever cause including, without limitation, from fire or negligence. The Resort is not my Bailee in any way. Squaw Valley Resort, LLC and Alpine Meadows Ski Resort, LLC are not in any way be liable or responsible for the protection or preservation of my property or any injury to myself, any co-users, or any of my guests.
2. I will not modify, alter, or intentionally damage the Locker or locker room. Any damage will be immediately reported to the Locker Room staff. I will be responsible for any and all modification, alteration, and/or damage to the Locker, except for ordinary wear and tear.
3. I will not leave any electronic devices, tools, or other equipment plugged in, operating, or otherwise unattended in the Locker or Locker Room.
4. I will abide by all Locker Rules and/or Locker Room Rules established from time to time by the Resort. Violation of such rules or breach of this agreement is cause for this agreement to be immediately terminated by the Resort upon which no prorated refund will be granted. My agreement to abide by such rules includes, but is not limited to:
 - a. I will not leave items unattended in the common areas.
 - b. I will place all skis and snowboards in the provided racks when this equipment is not inside my locker.
 - c. I will not leave items above the lockers or on benches, chairs, or any other seating areas (this includes but is not limited to bags, backpacks, helmets, jackets, gloves, etc.).
 - d. I will not leave skis, snowboards, boots, ski poles, or any other equipment in the rack for longer than 15 minutes at a time.
 - e. I will not leave my Locker unlocked when it is unattended by myself or any co-user.
 - f. I understand that items found by staff in violation of rules may be collected, placed in the Lost & Found, and/or turned in to Resort Security.
 - g. I will not bring alcohol, tobacco, illegal substances, or weapons into the Locker Room, or place them in the Locker.
 - h. Children age 16 or younger, and all guests, must be accompanied by User while in the Locker Room.
5. If a renewal of this agreement is offered to me by Resort, I will pay the renewal payment by the due date set by Resort and this agreement will automatically renew.
6. If a renewal of this agreement is not offered to me by Resort, or if this agreement otherwise expires or is terminated, I will remove my lock and contents from the Locker and Locker Room at the end of the winter season.
7. Resort may terminate this agreement without cause upon not less than ten (10) days' notice to me.
8. Upon non-renewal, termination, or expiration of this agreement, I will immediately unlock and remove my contents from the Locker and Locker Room. If I do not do so within 15 days' written notice, the lock on and contents in the Locker will be deemed as abandoned property and Resort may treat and dispose of it as provided under California law.
9. **Regarding guests and co-user children aged 16 and younger: I understand that misconduct by any of my guest(s) or my co-user child, or if I leave a guest or child unaccompanied in the locker room, such is cause for immediate termination of this agreement by Resort.**
10. I cannot sublet the Locker or assign, transfer, or delegate this agreement.
11. I will keep my above-written User contact and co-user information up to date and I will notify Locker Room staff immediately upon any change which may result in my execution of an updated agreement.
